### **A MESSAGE FROM THE PRESIDENT**

Dear Members,

The holidays are quickly approaching and our last meeting of the year is Thursday, November 19th. Individuals who contributed to our mission to research, record and preserve our county's history will be recognized. Also our guest speaker is Chief Andy Spell of the Edisto Tribe. I have met Chief Spell on several occasions and found him to be so interesting and knowledgeable on the history of his tribe and their connection to the Kusso/Natchez Native Americans.

The historical marker for the St. George School is still being finalized. Wallace Kizer has researched the history of this school and the information has been sent to Columbia; however, there is such a backlog, the process has been slowed down. I will keep you updated as progress moves forward.

On November 16, 2014, the Dorchester County Archives & History Center opened its doors. To date the archives and genealogy library are in operation. In the Archives, over 16,000 historic documents including rare, original documents, maps, early newspapers and several photo collections have been digitized. Thousands more have been donated and await digitization. In the Genealogy Library, over 80,000 names have been entered into the database. I urge you to contribute by lending or donating historical documents and your family histories in an effort to preserve our county's history. Please call Christine Rice at 843-563-0053 to set up a time to meet.

In October, Dorchester County Council gave more space in the old courthouse to help our efforts in developing the History Center/Museum. This center will exhibit the history of Dorchester County through artifacts, displays, audio and visual aids.


### **A View Of The Past**

**Edisto Kusso-Natchez Chief Speaker At UDCHS Meeting**

The Upper Dorchester County Historical Society will meet Thursday evening, November 19<sup>th</sup> at 7:00 at the historic Koger House (ca 1780's), located on the Wire Road three miles west of Grover.

The Guest Speaker will be Andy Spell, Chief of the Edisto Kusso-Natchez Tribe. At 37 he is the youngest chief to serve the Edisto Tribe so far. He has been active in the tribe since 1987. Spell graduated from Summerville High School and attended Trident Technical College. He is presently employed as Emerson/Liebert Service Manager, Cullum Services, Inc. Chief Spell was elected to the Edisto Tribal Council in 2003 and has served the tribe continuously since then. Spell was appointed Vice Chief in 2001 and served in that capacity until he was elected chief. He is also the tribal appointed historian. He worked on the Edisto Kusso-Natchez Tribe's state recognition petition, which the tribe received in 2010. Chief Spell has also assisted in registering or enrolling 540 tribal members. In addition, he is lead singer of the Edisto Tribe's drum group since 1991. The Kusso Tribe dates back to the 1600's in the low country. The two tribes united over time. Chief Spell will relate the history of these early Native Americans.

The UDCHS recently received a dining table believed to have been from the 1850's, though the exact date is not known. . The table was donated by Norman Sinkler Walsh and Marcy Stoney Walsh and is from the Eutaw Plantation (pictured above) which was built by Norman's ancestor, William Sinkler, in 1808. Mr. Walsh is a direct descendent of William Sinkler born Nov. 2, 1787 in South Carolina. It was dismantled in 1941 just before the land was flooded by Lake Marion. Along with the table, several pictures and a map were also donated.
